

Decision taken	To confirm the appointment of Metro Dynamics Limited to undertake the remaining Market Town Master Plans for East Cambridgeshire (Ely, Soham and Littleport).
Authorisation <i>(delete as appropriate)</i>	At its meeting on 28 March 2018, the Combined Authority Board approved the sum of £50,000 to develop a Masterplan for each market town (total budget of £550,000). [Minute 170 refers].
Background Information	<p>The St Neots Master Plan was completed in 2018. Metro Dynamics have been working on the next tranche of reports. In partnership with Fenland District Council, they are producing the Market Town Master Plans for each of its four market towns: Whittlesey, Chatteris, March and Wisbech. They are also working with Huntingdonshire District Council on the preparation of Market Town Master Plans for their three other principal Market Towns: Huntingdon, St Ives and Ramsey.</p> <p>MACE Limited, the Combined Authority's project management consultants have procured Metro Dynamics Limited via the Crown Commercial Services framework [ref RM3741] to undertake the remaining Market Town Master Plans for East Cambridgeshire (Ely, Soham and Littleport).</p>
Alternative options considered.	<p>The decision implements a previous decision of the Combined Authority.</p> <p>Given Metro Dynamics Limited's role with the other Market Town Masterplans they will be able to build effectively on their previous work and expertise on market towns in the Combined Authority's area. They are familiar with the industries and key individuals who shape the area and understand some of the challenges which are particularly acute. Their appointment would enable them to take this area-wide analysis and focus in on how the solutions we have identified can be applied to the market towns Ely, Soham and Littleport.</p>
